A network of French research-funding agencies sign a joint declaration promoting open science

In France, the National Research Agency (ANR), French Agency for Food, Environmental and Occupational Health & Safety (ANSES), National Cancer Institute (INCa), National Research Agency on HIV/AIDS and Viral Hepatitis (Inserm/ANRS) and Agency for Ecological Transition (ADEME) signed a joint declaration on 29 June 2020 to promote open science. This agreement underlines their ambition to develop a joint approach for disseminating and sharing knowledge more widely.

Carrying on from the National plan for open science¹ launched on 4 July 2018 by Frédérique Vidal, Minister of Higher Education, Research and Innovation, the national research funding agencies – ANR, ANSES, Inserm/ANRS, INCa and ADEME – decided to set up an exchange network in order to develop a joint approach to promoting open science. This approach seeks the unrestricted dissemination of research publications and data in order to facilitate broad access to knowledge and to harmonise practices across research communities.

In response to a growing need to improve access to research publications and data, and following a year of discussions, the network has set out the key role of open science in a jointly drafted statement.

In this way, the agencies are demonstrating their shared attachment to the key principles of open science;

- ✓ promoting free access to scientific publications;
- ✓ enabling open access to research data based on the principle: "as open as possible, as closed as necessary";
- ✓ sharing practices and procedures for assessing the scientific quality of projects, in compliance with the San Francisco declaration;
- ✓ informing beneficiaries and raising awareness by sharing good practices;
- ✓ opening data relating to the projects funded² by each institution in accordance with the Open Government Partnership³ and in compliance with France's Digital Republic Act⁴;
- ✓ publishing an annual review of the initiatives and measures implemented to promote open science.

A national agency working in the public interest, ANSES comes under the responsibility of the French Ministries of Health, the Environment, Agriculture, Labour and Consumer Affairs. It operates the National Research Programme for Environmental and Occupational Health (PNR EST), financed from budgets delegated by the Ministries of the Environment and Labour, as well as funds from partner institutions. In this context, the Agency issues two calls each year for research projects, essential tools for developing scientific knowledge with which to support public policy-making and health risk assessment work in its field of competence.

Established by the Public Health Act of 9 August 2004, the National Cancer Institute is the State agency providing health and scientific expertise in the field of oncology, with responsibility for coordinating cancer prevention initiatives. Through its integrated vision of different types of cancer and the related health, medical, scientific, social and economic aspects, the Institute seeks to support patients, their families, health system users, the general population, health professionals, researchers and decisionmakers in the fields of prevention, screening, care and research.

The Research Agency on HIV/AIDS and Viral Hepatitis (Inserm/ANRS)

The ANRS was established in 1988. Its role is to oversee, assess, coordinate and fund research programmes in its thematic fields, whatever the area of science concerned (fundamental, clinical or epidemiological research, or relating to human and social sciences, public health and vaccination). In France, the ANRS brings together researchers and doctors in all fields, reporting to research organisations (Inserm, CNRS (French National Centre for Scientific Research), Institut Pasteur, IRD institute), universities, hospitals or associations. Elsewhere, working primarily in eight countries, the Agency brings together researchers from the Northern and Southern hemispheres to work on research projects targeting national health priorities.
