# Singapore and France sign Memorandum of Understanding to enhance cooperation on food safety

On December 14, 2020, the Singapore Food Agency (SFA) and the French Agency for Food, Environmental and Occupational Health & Safety (ANSES) signed a Memorandum of Understanding to promote improved scientific and technical cooperation between the two national agencies in the area of food safety.

2 The MOU was signed by Mr Lim Kok Thai, Chief Executive Officer of SFA, and Mr Roger Genet, Director-General of ANSES. The signing was witnessed by Dr Amy Khor, Senior Minister of State for Sustainability and the Environment, Singapore, and Mr Franck Riester, Minister Delegate for Foreign Trade and Economic Attractiveness, France.

3 The MOU demonstrates Singapore and France's commitment to strengthening cooperation in the field of food safety to safeguard the health of consumers, by enhancing the exchange of knowledge and know-how, and reinforcing their research cooperation and expert assessments. Potential areas of collaboration include: a) risk assessment of chemical and microbiological food safety hazards; b) testing programmes for chemical and microbiological food safety; c) safety assessments of novel foods; and d) emerging food safety risks.

4 Mr Lim said, "The food system has become increasingly complex and globalised. SFA will continue to forge strong partnerships with our counterparts from like-minded countries to keep Singapore's food safety regulatory framework robust and stay abreast of global food safety developments."

5 Mr Genet said, "This MOU will help bring us closer in the domain of food safety, through shared activities in research, surveillance and risk assessment, thereby reinforcing the scientific expertise production and public health decision-making, and the trust of citizens. This is an ever more important concern in the current health crisis."
